VISA REQUIREMENTS

All applicable visas as per itinerary have to be obtained before departure. It is the sole responsibility of the guest to identify and obtain all necessary travel documents and have them available when necessary. These appropriate valid travel documents such as passports and visas are required for boarding the ship and entry into the countries to be visited on the guest's cruise. Guests who do not possess proper documentation may be prevented from boarding the ship or entering a country to be visited on their cruise and may be subject to fines. No refunds will be given to individuals who fail to bring proper documentation.

Documentation:

As visa and documentation requirements vary by country and are subject to change, all guests are urged to contact their travel professional, local immigration office, or the embassy or consulate for each country they will visit on their cruise to verify current entry requirements. It is the guest's responsibility to obtain required visas and other documentation prior to sailing, including vaccinations for infectious diseases.

Canada: Due to stricter Canadian entry requirements, immigration officials have advised NCL that citizens from certain countries require a valid Temporary Resident Visa (TRV) in order to visit or transit Canada. Passengers who are not U.S. or Canadian citizens should check the following web site for a listing of restricted nationalities to determine if a TRV is necessary: <u>www.cic.gc.ca</u>. Subsequently, passengers belonging to nationalities that require a visa will be denied boarding if they do not possess such a visa. Exceptions will be made for U.S. Alien Resident Card (ARC) and Canadian Residency Permit (CRP) holders.

Note: Effective July 14th, 2009, Mexico and Czech Republic were added to the list of nationals who require a visa to travel to Canada.
